#### **OFFICERS' REPORTS**

## Executive Officer Lt/C Raymond W Tilton, AP:

Commander informed the members that Ray is recuperating very well from surgery and would welcome a card or note.

In his absence, the Commander commented that the Clean Water Act has passed, and we need not worry about permits for the rain to run off our boats. Applause.

**Jim Curran, SN** was absent, there were no reports for Boat Show or Vessel Safety Checks, though the Commander announced we've had a great year, and there will be a report in November.

### Education Officer Lt/C Ed Walsh, SN: See the website for schedules and sign up online.

Sail Trim Seminar this summer was attended by 13 people, and generated some interest in the Sail course as well as other courses, approximately 10 students have signed up already for various Fall offerings. The committee will contact others who are eligible for advanced grades to encourage them to sign up.

There is a Seamanship class and Senior Navigation class, both starting in October. AP begins in January 2009.

We will schedule an Instructor Certification class if there is interest. One student has already requested it.

### Administrative Officer Lt/C Carol Quinn-LeBrun, S:

#### Secretary Lt/C Karen Arcisz, JN:

#### Treasurer Lt/C John Hagar, AP:

Financial Report, about \$2,000 in checking. Fidelity runs between \$19,000 and \$22,000. Everything in order. Still working on Picnic costs, waiting for receipts. Expect net cost to the Squadron will be about \$300 to \$400 total, John believes that the Picnic is worth the cost. It was moved and second to approve the Treasurer's report as summarized. Passed unanimously by voice vote.

John again reminded members any checks made out to the squadron must read 'Beverly Power Squadron' as this is the legal name we have at the bank and as our registered state entity name. Checks made out to Beverly Sail & Power Squadron will not be accepted by the bank.

### **OLD BUSINESS/ GENERAL DISCUSSIONS**

West Marine USPS Days (Sept 13-14) has been cancelled due to lack of interest/participation.

The Commander gave a short explanation of a confidential membership matter that had been discussed at the June 4 E-board meeting and originally scheduled for a special members' meeting after the Annual Picnic. In August it was decided by the Bridge and others involved to table this matter until our September or October meeting. Discussion ensued. Generally reaction was positive. After several minutes of questions and comments, the motion was made that the members present, comprising a quorum, were in agreement with the proposed resolution to this issue and that the Bridge should take appropriate action when the timing seems right to do so. Seconded and passed unanimously by raised hand vote. Some discussion; motion to have Commander facilitate getting a letter to the Harbormaster in Salem and possibly in Beverly making this request. Seconded and passed. Commander has directed Secretary to expedite this request to both the Salem and Beverly Harbormasters.
